The <u>subject of study</u> of the educational discipline "State law of foreign countries" is constitutional relations, which determine the basic principles on which order and freedom in a certain state are based. The subject of the state law of foreign countries is primarily and mainly socio-political relations, which are formed during the interaction of an individual, collective or society as a whole with the state, with public authorities.

The mass discipline program consists of the following meaningful modules:-State law of foreign countries: general characteristics;

-State law of foreign countries: special part.

State law of foreign countries is a set of norms that establish the foundations of the social system, the order of formation, organization and competence of the most important links of the state mechanism, the political and territorial organization of the state, and also determine the foundations of interaction between the state and the individual.

The main sources of this field are: Constitutions, normative legal acts, regulations of parliaments, acts of constitutional control bodies, acts of local self-government bodies, constitutional treaties, court precedents, sources of a religious nature, constitutional customs. State law of foreign countries, being one of the branches of constitutional and legal sciences, studies norms and constitutional and legal institutions, social relations regulated by them, the practice of implementation of norms and institutions of constitutional law, analyzes the regularities of their development in foreign countries.

# 3. The purpose and goals of the discipline

The goal of studying the educational discipline "State law of foreign countries" is the formation of students' theoretical and practical knowledge in the field of constitutional law of foreign countries, acquiring a general idea of the content of the main institutions of constitutional law on the example of many countries of the world.

The main goals of studying the discipline "State law of foreign countries" are the students' acquisition of knowledge about the constitutional and legal systems of foreign countries, which develops the general professional culture of the future lawyer, as well as laying the foundation of the general legal culture, legal thinking, developing students' ability to think independently and

express your thoughts in a clear and understandable way.
